**NOTIFICATION FOR CONTRACT APPOINTMENT**

Bangalore Metro Rail Corporation Limited, a Joint Venture of Government of India and Government of Karnataka, is a Special Purpose Vehicle (SPV) entrusted with the responsibility of implementing the Metro Rail Project in the city of Bangalore.

BMRCL invites applications from qualified and experienced retired personnel for appointment to Engineering positions in the Project Wing. All appointments proposed will be on "contract basis" only.

Total number of posts is 50 which include all the four categories indicated below viz. Deputy Chief Engineer, Executive Engineer, Asst. Executive Engineer & Assistant Engineer.

The maximum age limit for all the posts is 60 years.

**I. QUALIFICATION AND EXPERIENCE**

Sl. No	Name of Post	Age Limit (Years)	Experience Criteria
1.	Deputy Chief Engineer	60	Should have retired as Deputy Chief Engineer or Equivalent from Central Govt/PSUs service having experience in major infrastructure projects and experience in underground works is preferable.
2	Executive Engineer	60	Should have retired as Executive Engineer or Equivalent from Central Govt/PSUs service having experience in major infrastructure projects and experience in underground works is preferable.
3	Asst. Executive Engineer	60	Should have retired as Asst. Executive Engineer or Equivalent from Central Govt/PSUs service having experience in major infrastructure projects and experience in underground works is preferable.
4	Assistant Engineer	60	Should have retired as Assistant Engineer or Equivalent from Central Govt/PSUs service having experience in major infrastructure projects and experience in underground works is preferable.

**Note:** Candidate must have experience in large infrastructure project execution. Experience of underground construction will be preferred. Candidate must be familiar with Contract Management, QA/QC, Safety Implementation, Programme Monitoring etc.

## II. PAY

Besides the above, employees will be extended medical and personal accident insurance cover & contribution to superannuation fund, CUG mobile facility and conveyance facility as per rules of the Company.

## III. PERIOD OF CONTRACT APPOINTMENT

1. The tenure of contract appointment will be 3 years.
2. The contract of appointment may be terminated by either side by giving **3 months notice** or by paying the contractual remuneration of three months in lieu of notice period, if the circumstances so warrant. However, BMRCL reserves the right either to accept or reject the resignation depending on requirement of the project.

## IV. CONDITIONS

1. Candidates working in BMRCL in the same post are not eligible to apply.
2. Candidates working in BMRCL who desires to apply for the post of Dy.CE, EE, AEE & AE should have a minimum of 3 years' experience in the post of EE, AEE, AE & SE respectively in BMRCL in addition to all conditions mentioned in the Notification.
3. Candidates who have been shortlisted will only be called for interview.
4. The experience is post qualification and the minimum required. Mere possession of minimum experience does not confer any right to be called or interview / selection.
5. Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection/appointment shall be a disqualification.
6. Selection will be through interview by a Committee constituted by the Competent Authority.

## V. SELECTION

1. Candidates should fill in the application **on-line**, take a printout of the same and submit along with copies of all certificates in support of qualification and experience prescribed for the post. Candidates who fail to send hard copy of the on-line application along with relevant documents will not be considered even though they have submitted application on-line.

2. The application of any candidate found guilty of impersonation or submitting fabricated documents or making statements, which are false or incorrect or indulging in suppression of facts, attempting to use unfair means for the purpose of recruitment, will be liable for rejection.
3. The candidates shall have to appear for interview as and when called, at their own cost.

#### VI. MISCELLANEOUS

1. **Documents in support of qualification and relevant experience shall be sent along with the application. Non-submission of documents along with the application, will lead to rejection of application at any stage during the process of recruitment.**
